### **NEW BUSINESS**

- o Carl DeMaio
  - o Swearing in of the 2009 Board.
  - o Fixing the city:
    - o Thank you to all the volunteers who have given countless hours to their community.
    - o He will work just as hard down at City Hall.
    - o He wants to help create a city government we can be proud of; this will require balancing (1) the budget and paying down debt, (2) providing safe and clean neighborhoods, (3) having honest public leaders that lead by example and that we can trust, and (4) creating jobs for the current environment by helping people create new small businesses without penalizing them.
    - o The budget problem and the abuses are mind-numbing. The state has run its finances like a bunch of drunken sailors. They've run a bar tab and have a hang-over. Government is the only business where you can cut services while raising fees.
    - o City tax payers are on the hook to bail out the retirement system loss of \$743 millions.
    - o Labor negotiations start next month.
    - He is working on the shopping cart issue; it will be unveiled in the next few weeks.
    - o Question: Did the prior council work for the people or for themselves? Answer: Instead of wanting to shrink the city government, they wanted to build a brand new City Hall building. They were raiding reserves. The current council does, but it is on a very short leash.
    - Question: How do we get involved?
       Answer: Call them, contact them; let them hear you.
    - O Question: If the city goes bankrupt, the pensions will be dead. Why can't the Mayor go to Washington for a bailout for the city?

      Answer: Regarding bankruptcy it sounds really good and easy, but it's not. The challenge is that the judge will look at liabilities (pensions, debts, bonds, etc), at the annual costs (police, clean waters, etc), and at the revenues (tax base). The judge will require liabilities to be paid off, will look at the assets (Balboa Park or Torrey Pines, for example) and will have us sell them to developers. A judge, who is not elected by the people, will look at the balance sheet and will treat this bankruptcy as a business bankruptcy.
    - Question: How do the business licenses work?
       Answer: The city looks at tax returns; if income is reported as small business income (schedule C/1099), you are required to get a business license. If you rent out a property in San Diego, you are a small business. The City is going back and issuing fines. His office is fighting these fines.
    - Question: Why can't we resolve the pension problem?
       Answer: The Fringe rate had not been calculated by the City of San Diego until Carl asked about it. The national rate is 30% for most companies;

government national rate is 36%. The City of San Diego's rate is 61.4% - almost double the national government average. New pension system for new hires is needed. For employees who already vested these benefits – in order to pay them the net cost (inc. benefits), charge more for 'Cadillac' benefits; people can opt out. People closer to retirement will not opt out, but all others probably will. ERISA is managed by the pension benefit corporation and insures all pensions. ERISA takes over bankrupt private companies' pensions and pays a certain percentage. This does not apply to governments. We need specific labor contracts.

- Question: Can all elected officials give up their pensions?
   Answer: Carl is the only one. We can't force them to do that.
- Question: Who will take on your watchdog role on the outside now that you're on the inside?
   Answer: He's hired a budget watchdog internally. He is creating a project where we will have an update to the Citizen's Budget that helped create public awareness. He wants the recommendations reviewed and a task force to come up with new recommendations.
- Question: How can we help you?
   Answer: Volunteer as much as you can. It's going to get worse and communities will need its citizens' help. Speak up and raise your voice.
- o Mira Mesa Maintenance Assessment District (Tom Derr)
  - o Rates for Maintenance Assessment for Mira Mesa and Scripps Ranch have not been raised in years. The Mira Mesa assessment was fixed at \$10/year by a ballot measure voted on in Mira Mesa in 1997, and can increase to \$11.81 corresponding to the cost of living index without a new vote. The Scripps Ranch Maintenance Assessment District, which has much higher fees, has run out of money and they will need to increase their rates.
  - There is over \$600,000 in reserves for Mira Mesa. It either must be spent or returned. The MMMAD authorizing agreement restricts the use of this money to landscaping, lighting and litter removal along specified major streets. The MMMAD committee would like to do projects outside the scope of the current agreement.
  - o The proposed budget is posted on the Mira Mesa Town Council website. Approval is needed tonight. The budget is not changing until 2010. The new budget includes \$50,000 for a ballot measure to authorize an increase in the scope of the MMMAD and \$20,000 for the Engineer's Report. The budget deadline is end of January.
  - o Motion is made to approve the budget; motion is seconded. Motion passes. Budget is approved as is.
  - o Motion is made by to add members to the committee. The motion is tabled until the February meeting to allow for further review.
  - Question: What do you need to review the bi-laws?
     Answer: More volunteers. You don't need experience to volunteer.
