- o Police Department (Officer Jeff Carter)
 - o Summer has been rather uneventful.
 - o 7/10 Peeping Tom on Camino Ruiz.
 - o 7/10 9300 block of Hillary Dr. Strong arm robbery of a 60 year old female; a man stole her lunchbox. He has not been apprehended
 - o 8/2 Copper wire was stolen from a construction site. Someone was arrested.
 - o Movie Theater break-ins and fights.
 - o Tickets are being issued for using cell phones while driving.
 - o Crime stats are available on the police website eWatch page.

- o Crime stats are doing much better for San Diego.
- City Councilman Carl DeMaio (John Ly)
 - o Thank you for the 4th of July parade best parade!
 - o Camino Ruiz Trail is open.
 - o Shopping carts he is looking for funding to fix this problem. Vehicle abatement has money; if shopping carts could be considered abandoned vehicles, the funds could come from there.
 - o Salk Elementary City Attorney's office is working with the School District.
 - o Ethics Commission Board of people appointed by City Council to investigate complaints filed by residents regarding unethical use of funds. Frye and DeMaio want to change the way nominees are elected.
 - Prop C passed 1000 days ago and the city has done nothing but 1,100 hours of negotiation and \$124,000.

 - State Budget will remove funds from local governments.
- State Assemblyman Nathan Fletcher (Oscar Urteaga)
 - \$26 billion deficit has been reconciled with the most recent compromise.
 - \$15 billion in cuts from government spending
 - Modernize the enrollment process to reform Medi-Cal and imposes tough anti-fraud standards to reform In Home Supportive Services
 - No new taxes
 - Keeps the community safe no early release of prisoners or devastating cuts to local law enforcement.
 - Question: How are vital services are defined? Wasn't healthcare for children and elderly greatly reduced? Will fewer people have healthcare due to this?
 Answer: Health and Human Services were cut dramatically, but those were increases from prior years that were cut. Nothing was eliminated. There are stricter guidelines for applying for welfare and heath care.
 - Comment: UT on July 21st indicated that the most hit were the poor, the children, the elderly, and the disabled.

NEW BUSINESS

- o Brian Bilbray US Congressman
 - Fourth of July Parade was a great event; thank you for inviting me.
 - Why I vote the way I do:
 - I was mayor and on the board of the County Supervisors; this is my background and the local government experience I draw from when I vote.
 - o This budget scares me because the local government people are being cut out due to the lack of local government experience up in Washington.
 - o Ethanol pollutes more than anything; we should be using algae energy. Every California supported my bill in the 90s to remove ethanol from gas. A new bill subsidizing coal is a terrible mistake. Don't make a fortune polluting the environment when you claim you are cleaning it up. It is better to burn regular gas than ethanol for the environment. Please look into the Waxman-Marquey Bill. Stop signs create more pollution than yield signs; cops prefer stop signs because it's easier to give tickets. Wind, hydro, and nuclear energy are the cheapest.
 - o Government must change the way it does things. The government creates the box the businesses must remain in.
 - o The greatest threat to the environment comes from the smoke coming out of the backroom deals.
 - o Comment: World Health Organization rates the US' healthcare 37th in the world.

- Response: Insurance companies need to be reined in. Lawyers must be controlled. Patients should be allowed to cross state lines to create competition. The Veterans Program will be the standard for America. Canada has 30 million people 10% of America's population. Medicare does not offer as many tests and preventive medicine as the private insurance companies do.
- Question: Non-Profit co-ops with an inter-state regulatory body is a great idea.
 Has anyone considered marrying the credit union concept to the exchange concept?
 - Answer: Yes, but it would create a monopoly.
- Comment: Healthcare should be separated from employment.

 Response: Washington doesn't admit its mistakes nor learns from them.
- Question: Why would socializing healthcare doom the system? It's working in France. Is it because it would hurt the insurance companies?
 Answer: 80% of medical breakthroughs happen in the US.
- Question: Do you intent to vote for the Affordable Heath Choices Act (HR 3200) http://www.opencongress.org/bill/111-h3200/show?
 - Answer: I have not read it yet. It will cost over a trillion dollars over 10 years. There is not one word about tort reform. Let's put the squeeze on the insurance companies and the lawyers.
- O Question: Where do you stand on off-shore drilling; have you voted pro-taxing oil? Answer: No. We are not being aggressive enough to find true alternatives. We have enough money, but we are sending it to the wrong groups. The scientists at Scripps have developed algae energy, but they cannot get a permit in California and are considering moving to New Mexico.
- o Question: What is your perspective about the Obama Administration? Answer: You are not elected as a democrat or a republican. You have to use your own brain. I was attacked and told I was not a true Republican because I don't always side with Republicans. You have to work with the other side of the aisle to do right when it's needed.
- o Comment: I want to personally thank you for my healthcare. Medicare has replaced two hips and two cataracts. Medicare is a wonderful system. HR 3200 is a worthless attempted compromise. HR 676 has been there for years and will grant Medicare to everybody. I urge you to have it sent to CDO. Will you support it?
 - I will not commit to support it. The physicians that are the main stay in this country are retiring within this decade. The next big crisis coming down is where we will get the doctors.
- Comment: Rx drugs are much too expensive and pharmaceutical companies must be controlled.
 - Response: San Diego is the place where miracles are created. Eliminating advertisement for Rx drugs and controlling litigation will lower the prices and not scare away the investors.
