 - o December beginning balance \$85,465.29; Income \$356.60; Expenses \$1,397.99; Net cash flow (\$1,041.39); Ending balance \$84,423.90.
 - Full year report 2010: Ending Balance is almost identical to starting balance. Budget had expected to spend more than income, but we received \$4,000 for rental of Street Fair banner district that made up the difference.
 - Looking for volunteers for Budget Committee
 - o Question: Why do we carry such a large balance?
 - Answer: Historically MMTC has been a very poor group. We are making money from Street Fair and haven't spent it. Gradually over time we have gotten closer to spending what we bring in annually.
 - o Question: Can we forecast returning membership dues to \$10/year?
 - Answer: Haven't heard it was a problem. We can consider it if we hear that it will increase membership from young people.
