Thanks for carrying on the tradition since 1975. Presentation also to Grand Marshal Hilda Rosales early settler moved to Mira Mesa in March 1970, still in same home. Introduced new rep. Liezl Mangonon. Worked for Tony Young and Myrtle Cole for past 8 years.

- a) SDPD Northeastern Division Officer Shannah Kanoa, Community Relations Officer Kenneth, filling in for Shannah. Crime overall is down. Question: Car break-ins and graffiti at Gold Coast and Hemphill. Have picture of graffiti. Send picture of graffiti and they will track down.
- b) SDFD Capt Flores, Public Information Officer. Battalion Chief. Busy since last meeting. Remodel of fire station in progress. Lightning strikes are causing fires, esp. north of us. Most fires in US are caused by lightning. Heat lamp that fell over outside caused the house fire on Flanders.
- c) Nextdoor.com Joleen. Way for people in local neighborhood to communicate with each other and with the police.
- VII. Presentation Panel Discussion: Medical Marijuana Consumer Cooperatives

Panel members: Assistant Police Chief Terrence McManus; Acting Deputy Director, Code Enforcement; Jeannette Temple, Development Project Manager II, Development Services.

- Q: Explain new regulations J Limited to 4 per council district and only in industrial and commercial zones. Requires conditional use permit.
- Q: How was limit decided on not sure, but there is also a distance limit of 1000 feet between dispensaries and 1000 feet from any child-oriented facilities such as parks and schools.
- Q: How are CUP's like or unlike other CUP's. Similar to other CUP's.
- Q: Over the last month found 6-11 illegal dispensaries currently operating in Mira Mesa. What is process to close them? M Dispensaries are not a permitted use and have been enforcing them. Those dispensaries operating now are not legal and when we find out about them start a

case against them. Report them if observed. Early on were putting green crosses on the Window, making themselves obvious. Now being less obvious. 619-236-5500.

Q: How long does it take to close a dispensary? Two full time positions dedicated to it. Try to identify operator, property ownership. Sent to City Attorney. Many cases open now in various stages of enforcement.

Q: Any other legal actions possible? T – Criminal enforcement. If there is criminal activity can take action. Since prop 215 police and code enforcement working side by side.

Q: Delivery services? J - Delivery services are not allowed.

Q: Do the CUP costs include any enforcement? Will there be any increase in enforcement. T – Not defined yet.

Forum continued with questions from the audience moderated by Secretary Jeff Stevens.

- b) Mayor Kevin Faulconer (John Ly). Why don't we have Marijuana at CVS? Because they have to meet Federal Requirements. 2-6 AM can't park RV's on the street. Also not more than 72 hours. Jly@sandiego.gov. There are patrols looking for them. Court ruled against City re Convention Center Expansion. Both City and State are looking at banning plastic bags. Miramar Road overlay starting in October.
- c) Assemblyman Brian Maienschein, District 77 (Rob Knudsen). Nextdoor.com someone committed a crime at a department store, picture posted, culprit turned himself in. Introduced college student working in office. Chris Panetta. Moving up to Portland. 6 bills passed. Human Trafficking bill increases sentence for trafficking. AB 1791. Currently 6 months for minors and adults. Doubles sentence for minors. AB1810. Animal Care facility bill. 14 days to return pet to owner; 10 days to place in home. Bill gives more flexibility on deadlines. AB 2632. State Licensing for Care Facilities. Background checks. Brian thanks MMTC for inviting him to parade.
