Mr. Pallera Mentioned the Sycamore-Peñasquitos 230-KV Transmission Line Project. The recommendation is currently to use Alternative 5 as the "environmentally superior alternative." The Council Office shares our concern for the possible disruption of businesses in the Miramar Road Area and is sending a letter to the California Public Utilities Commission. While other communities possibly impacted by the project were provided with a presentation on the various alternatives and asked to provide comments, Mira Mesa was skipped in this process. When advised by the Scripps Ranch Planning Group of its possible impact on Mira Mesa, the public comment period had already ended. The chair asked Rob Knudsen, the representative for Assemblyman Brian Maienschein, to express our concerns to the Assemblyman and ask for his support.

August Community Updates

Fentanyl

- Supervisor Dave Roberts is bringing legislation to the Board of Supervisors Tomorrow morning (August 2, 2016) that supports tougher penalties for people convicted of selling fentanyl illegally.
 - According to the DEA, fentanyl can be deadly for first responders because a lethal dose can be accidentally inhaled or absorbed through the skin.
 - Fentanyl is 50 times stronger that heroin and across the country, law enforcement officials and lawmakers are responding to a surge in fentanyl overdose deaths.

MMA Academy

 On Thursday, Supervisor Dave Roberts recognized MMA Academy on live TV for becoming a Live Well San Diego partner. The academy operates studios in Sorrento Valley and Oceanside and provides self-defense training to law enforcement, social service groups and the public.
