## 2. Approval of the Minutes

#### 3. Information Items

- a. MCAS Miramar Juan Lias reported that the MV22 DEIS review is ongoing. For more information, please visit www.mv22eiswest.com. Scripps Ranch will host a community discussion meeting on the EIS March 24. The USMC has released the accident report for the FA18 crash in University City. The accompanying JAG report will be available to the public via the FOIA release process. The USMC will provide the application form upon request. The MCAS Miramar base commander, COL O'Connor will be retiring on April 2.during a change of command ceremony.
- b. Council District 5 John Ly speaking for Carl DeMaio reported that the derelict shopping cart issue is under discussion with the California Grocers Association (CGA) to develop a pilot program funding high school groups to help collect carts. This will apply to CGA stores at the local level only. Park & Rec will place Salk elementary development on the city council docket in the April/May timeframe. The MOA between the city and school district is being finalized in preparation for the council meeting. Direct Access Route alignment at I-15 near Mira Mesa Blvd is tentatively planned for discussion/review in April. The trail from Camino Ruiz Park into the Los Penasquitos Canyon Preserve is under construction. Bruce Brown requested councilman DeMaio look into getting the Mira Mesa Community sign at the west end of Mira Mesa Blvd repaired or replaced.

trial period. A traffic study of the resulting patterns will be conducted during this period.
