1. Adoption of Draft Agenda:

- a. Item number 2 was broken out into 2(a): Minutes from November 2011; and 2(b): Minutes from January 2012.
- b. Item 3(c) was added to the Agenda.
- Motion to approve agenda with these changes was made/seconded by Jeff Stevens/Bob Mixon. Motion carried unanimously.

2. Approval of Minutes:

- a. November 2011: Correction was requested on the spelling of Ted Brengel's name in the minutes for item 3(c). Motion to approve minutes for November 2011 with this correction was made/seconded by Jeff Stevens/James Ludwick. Motion carried unanimously.
- b. January 2012. An opportunity to request corrections was made available by the Chair. No corrections were requested and the Minutes for January 2012 were deemed adopted by unanimous consent.

3. New Business

a. Salk School Environmental Agreement Update – John Stokes, Facilities Development Project Coordinator, San Diego City Schools. Last Thursday (2/16/2012) notice of approval has been filed in Washington for the HCP/EA (Habitat Conservation Plan/Environmental Assessment.). Public review is a two-month period likely starting in March. The response period depends on the volume of comments. For the issuance of the Incidental Take Permit, there are two outstanding issues: SDUSD needs approval for a "Waste Discharge Requirements/Permit" from the Regional Water Quality Control Board. A meeting regarding this is currently scheduled for May 9. SDUSD also needs to finalize MOU with City of San Diego for land swaps.

Motion made/seconded by John Horst/Ted Brengel to write jointly to Congressmen Brian Bilbray and Senator Diane Feinstein thanking them for their assistance and requesting them to write jointly to U.S. Fish & Wildlife to affirm the progress and to note their desire to participate in a dedication ceremony on what would have been Dr. Jonas Salk's 100th birthday, October 28, 2014. Bari Vaz offered a friendly amendment suggesting the letter be circulated among the Board for comment and the vote to send it be held over to the March meeting, pending the next update from SDUSD. The friendly amendment was accepted, the question was called and the motion as amended carried unanimously.

- b. Walker Neighborhood Playground Upgrade Sheila Bose, Engineering and Capital Projects, Dept of Public Works: Item withdrawn. City wanted to take more money from FBA. We had an offer from "Kaboom" (a non-profit dedicated to developing playgrounds) to do the work for far less. City asked that the item be removed to allow review of these possibilities.
- c. Neighborhood Use Permit (NUP) for home business use Josh Malo Applicant, presented by Marvin Miles: Josh Malo manages Firestone in Mira Mesa. He wants to be able to have a home office business to retail firearms at a low volume. His house is fully secured and has a federal firearms license. Motion to support NUP request made/seconded by Ted Brengel/Pat O'Donohoe. Motion carried 12/1/1.
