- iv. Stone Creek plan calls for a central park in the middle of the development – committee asks that the park be completed early enough as residents are moving in
- c. Joint Subcommittees
 - i. Sorrento Valley Coaster Station Subcommittee (joint with Torrey Pines) – presented by Ken Kaplan
 1. SANDAG is requesting a ballot initiative for a half percent increase in sales tax in order to provide for a number of significant infrastructure funds for transit projects
 2. If passed, would still create a budget shortfall of \$15 billion after the tax – would require additional funds to be secured by SANDAG to complete full range of projects
 3. Sorrento Valley Coaster Station plan is reliant on the ballot initiative in order to be considered – otherwise it would remain an unfunded SANDAG project
 - ii. CPUC/SDGE&E Transmission Line Subcommittee (joint with Scripps Ranch)
 1. Ted Brengel - no updates
- d. Pedestrian Bridge Subcommittee
 - i. Bruce Brown – The committee met with the Principal and Vice Principal of Mira Mesa High School; issue will be taken to the school district
 - ii. Desire to look at a pedestrian crossing of some type to meet the needs anticipated with the park’s installation of new features/attractions
 - iii. Suggestion was also given to consider a pedestrian crossing at street-level
